



## 2012 Discover Orange Bowl Media Information

**Official Team Headquarters:** The ACC Champion (if available) will be headquartered at the Westin Diplomat Resort & Spa located on 3555 South Ocean Drive, Hollywood, FL 33019 and Nova Southeastern University will serve as the team's practice site. The BCS At-Large team will be headquartered at the Fontainebleau Resort & Spa located on 4441 Collins Ave, Miami Beach, FL 33140 and Barry University will serve as the team's practice site.

**Official Media Headquarters:** The Marriott Harbor Beach Resort & Spa located on 3030 Holiday Drive, Fort Lauderdale, FL 33316 will serve as the Official Media Headquarters for the 2012 Discover Orange Bowl. The press headquarters room will be located in Caribbean Ballroom (Sections I-III) on the first floor. All team and bowl materials will be available in the headquarters, as well as daily practice reports, schedule updates, notes and quotes. Hours of operations are from 9:00 AM to 6:00 PM beginning Thursday, December 29 through Wednesday, January 4, and 9:00 AM to 1:00 PM on Thursday, January 5.

**Media Credential Distribution:** All media credentials may be picked-up at the Official Media Headquarters of the 2012 Discover Orange Bowl in the Caribbean Ballroom (Sections I-III) beginning Friday, December 30 at 2:00 PM through game day, Wednesday, January 4 at 1:00 PM. After that time on game day, media credentials may be claimed at the Media Will-Call (located at Gate H at Sun Life Stadium) beginning at 4:00 PM. Proper identification is required at pick-up. NO MEDIA CREDENTIALS WILL BE MAILED.

**Media Headquarters Computer Workroom:** The media workroom will be located in the Key West/Palm Beach Rooms on the second floor. The room will be equipped with desktop computers, high-speed internet connectivity and a laser printer. The room also contains telephones, of which all long distance phone calls must be made through calling cards/credit cards. The workroom will be open from 9:00 AM to 10:00 PM beginning Friday, December 30 through Tuesday, January 3, from 9:00 AM to 1:00 PM on Wednesday, January 4, and from 9:00 AM to 1:00 PM on Thursday, January 5.

**Media Shuttles:** The Orange Bowl Communications Department will provide a courtesy shuttle from the Marriott Harbor Beach Resort & Spa Convention Center to Sun Life Stadium on the day of the game. Shuttles will run every 45 minutes from 3:15 PM through 5:30 PM and will pick up members of the media at the downstairs Convention area entrance of the Marriott Harbor Beach Resort & Spa Convention Center and drop off near Gate F of Sun Life Stadium. Following the game, the shuttle service will then transport members of the media back to the Marriott Harbor Beach Resort & Spa one hour after the conclusion of the game. The shuttle service will run continuously through 3:00 AM. Post-game pick-up will occur in front of Gate G.

**Game Day Multimedia Services:** Complimentary wireless, hard-wire and high-speed internet access will be available in the press box, auxiliary press area and Digital Media room. **Satellite Parking:** Satellite truck parking will be in the parking area outside Gate H (West end of Sun Life Stadium).

**Live Telecasts:** On game day, non-originating telecasters may originate live programming from the field until approximately 45 minutes before kickoff until after the network has concluded its coverage from the site. Live programming may resume after ESPN has discontinued its live coverage after the game. Television stations or networks may use up to three minutes of footage for television news highlights purposes during the 72 hours after the game. All footage must contain the ESPN logo throughout and must be accompanied by the graphic “Courtesy ESPN.”
